## Standardised Price List

All funeral directors are legally required to publish this Price List for a standardised set of products and services.

This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL - Also called an Essential or Simple Funeral (Funeral director's charges only)	£1850		
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.			
Our £1850 service fee is the total fee and is made up of the following 6 items			
Taking care of all necessary legal and administrative arrangements	£455		
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care	£150		
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's premises.	£465		
Providing a suitable coffin - this will be Oak Veneered, fully lined with fittings	£220		
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£1		
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£559		

UNATTENDED FUNERAL - Also called a Direct Cremation. Our service is a fixed fee and not a "Prices From" service.	
This is a funeral where family and friends may choose to have a separate ceremony, event or service for the deceased person,	
but they do not attend the burial or cremation itself.	
Unattended Burial (funeral director charges only).	£1400
Unattended or Direct Cremation (funeral director charges including coffin, cremation and Dr's fees*2).	£1200

For an Attended or Unattended burial funeral, the burial fee. *1	£300
